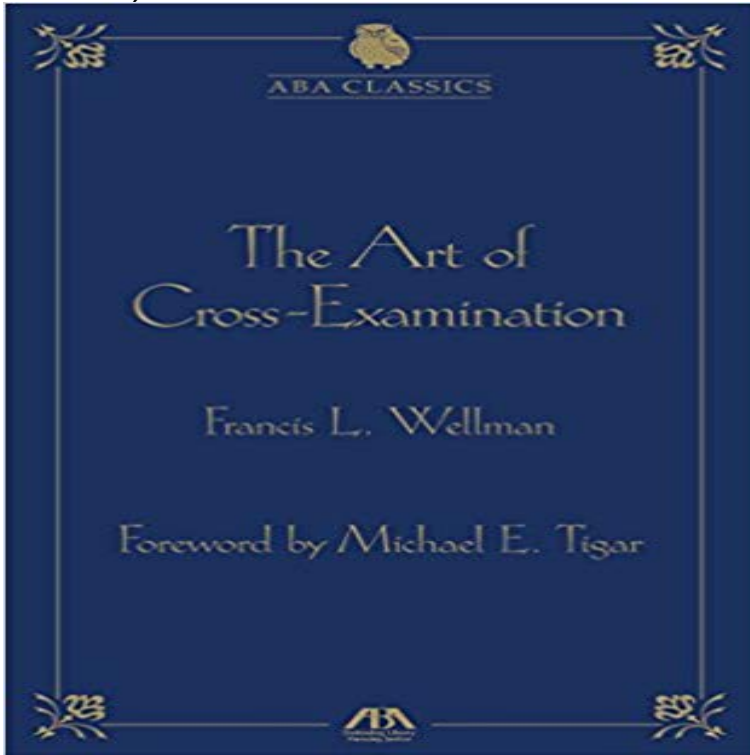


## The Art of Cross Examination by Francis L. Wellman (ABA Classics Series)
