The 2009 edition has been updated with the provisions of the so-called PRO IP Act that strengthens the civil and criminal laws against counterfeiting and piracy; amendments to the patent and trademark laws relating to the method of appointment of administrative patent and administrative trademark judges; the provisions of the Vessel Hull Design Protection Amendments of 2008, which amends the copyright law to specify that the design of a vessels hull, deck, or combination thereof, including a plug or mold, is subject to protection; the provisions of the Webcaster Settlement Act of 2008, which authorizes the entering into of agreements between representatives of copyright owners and performers on the one hand and webcasters on the other hand for the payment of royalties for the performance of sound recordings on the Internet. The CD-ROM also contains additional legislative history relating to patent reform efforts, including the text of A1145, as reported out of the Senate Judiciary

Committee, and the Final Judiciary Committee Report on A1145. Also included on the CD are the texts and legislative history of the Trademark Law Treaty (Singapore), the Patent Law Treaty, and the Geneva Act of the Hague Convention relating to industrial designs. These treaties have been ratified by the Senate but have not yet taken effect.
