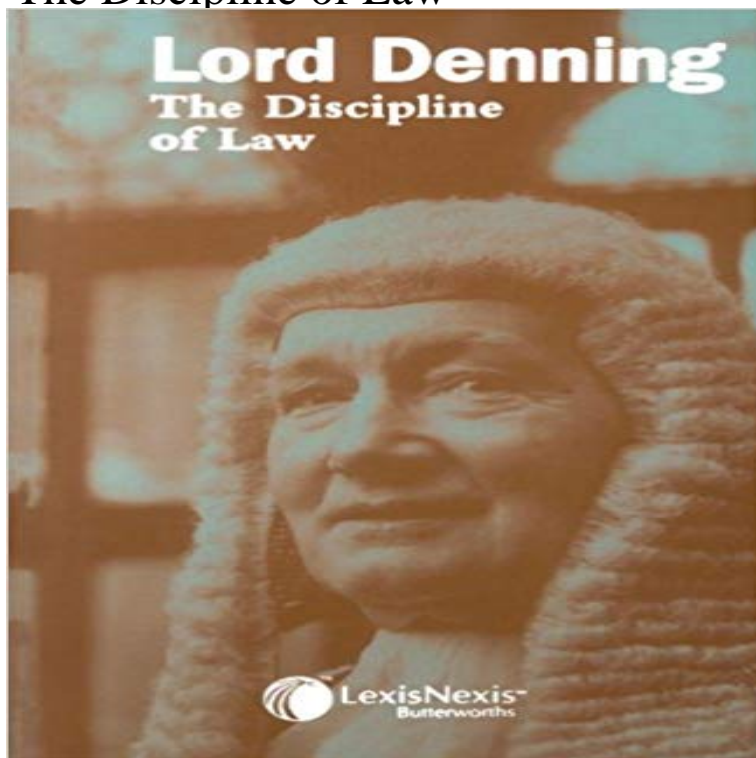


The Discipline of Law
