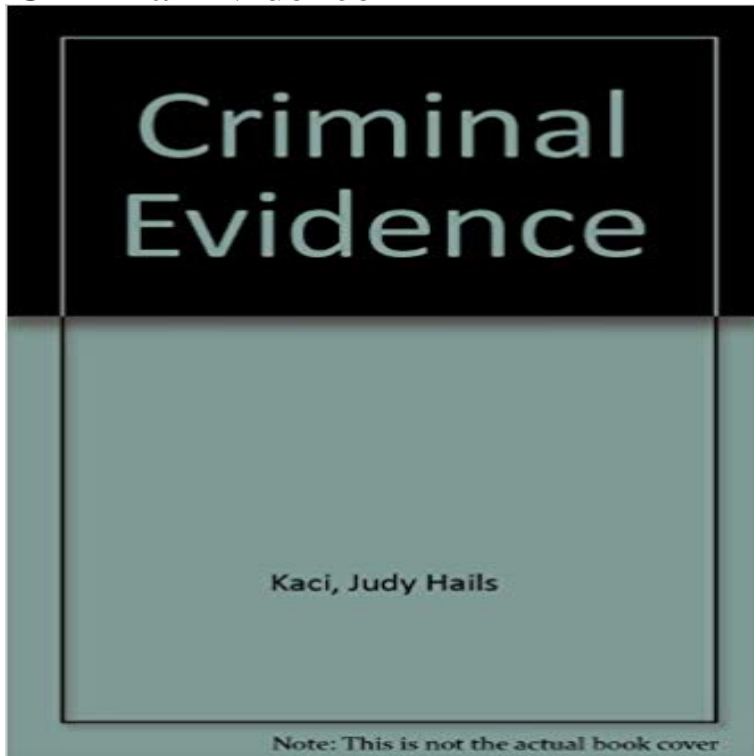


## Criminal Evidence
