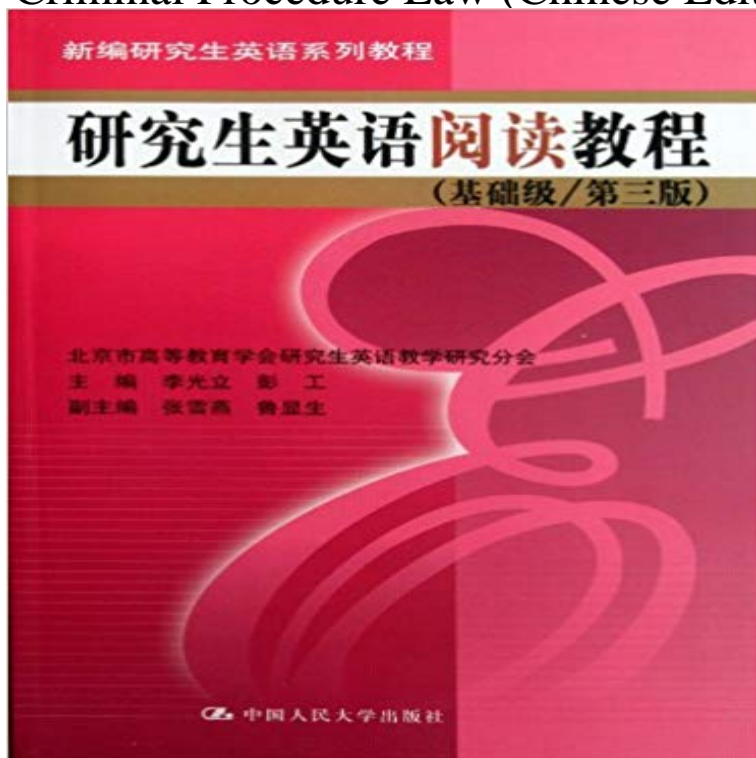


Criminal Procedure Law (Chinese Edition)
