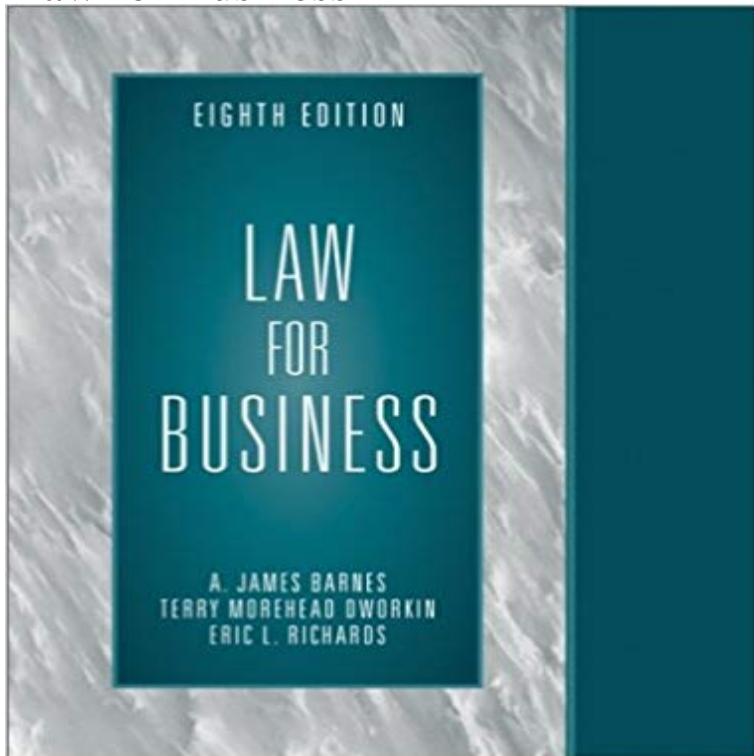


Law for Business
