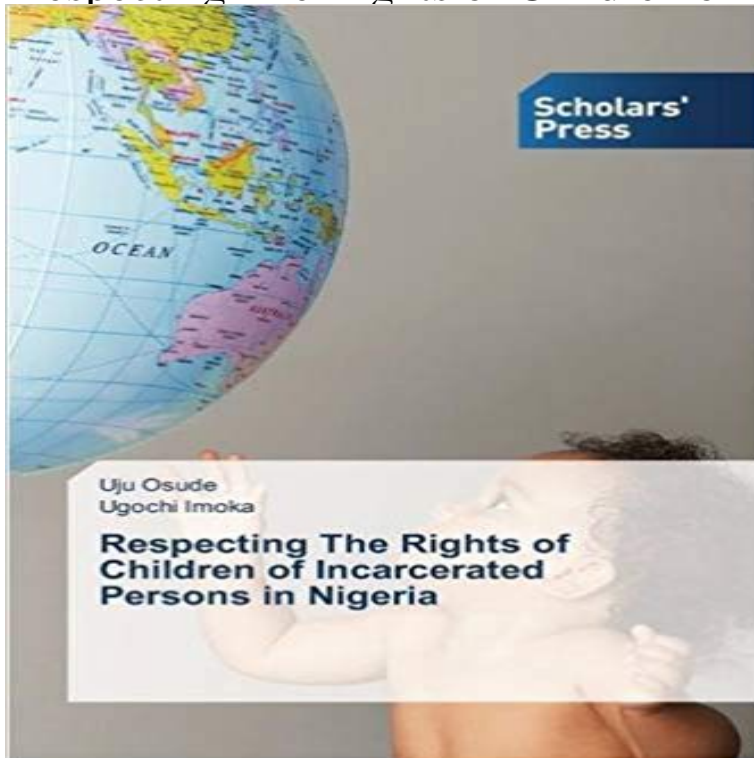


Respecting The Rights of Children of Incarcerated Persons in Nigeria
