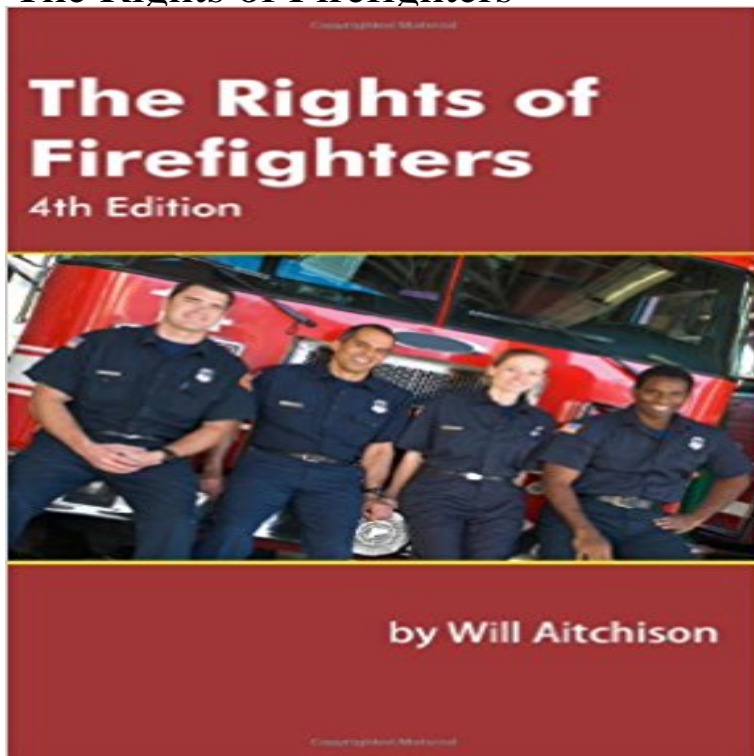


The Rights of Firefighters
