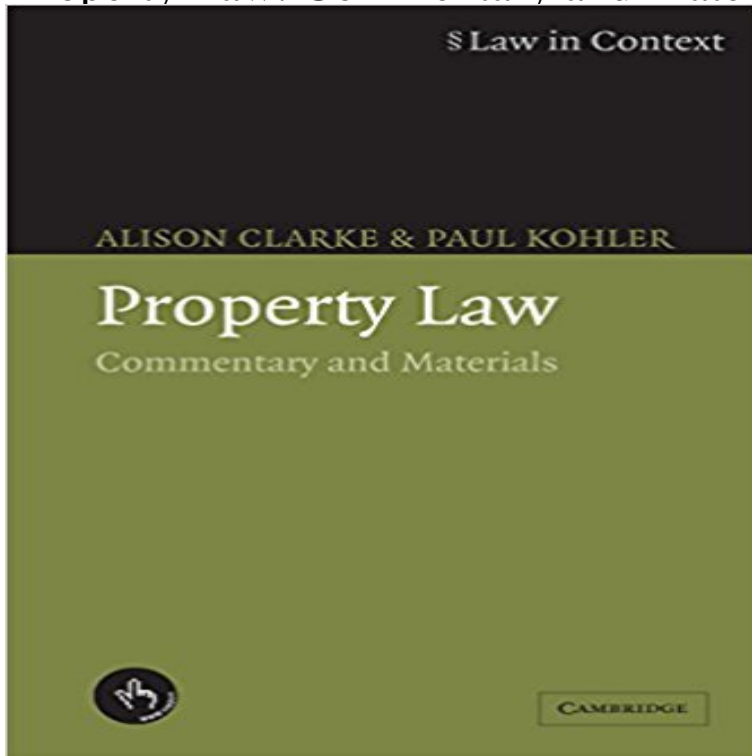


Property Law: Commentary and Materials (Law in Context)
