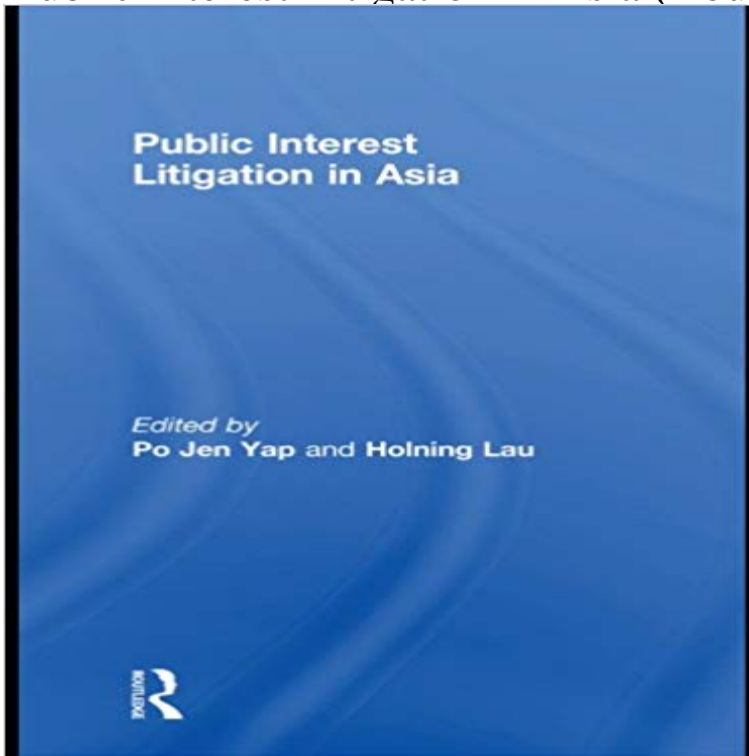


Public Interest Litigation in Asia (Routledge Law in Asia)
