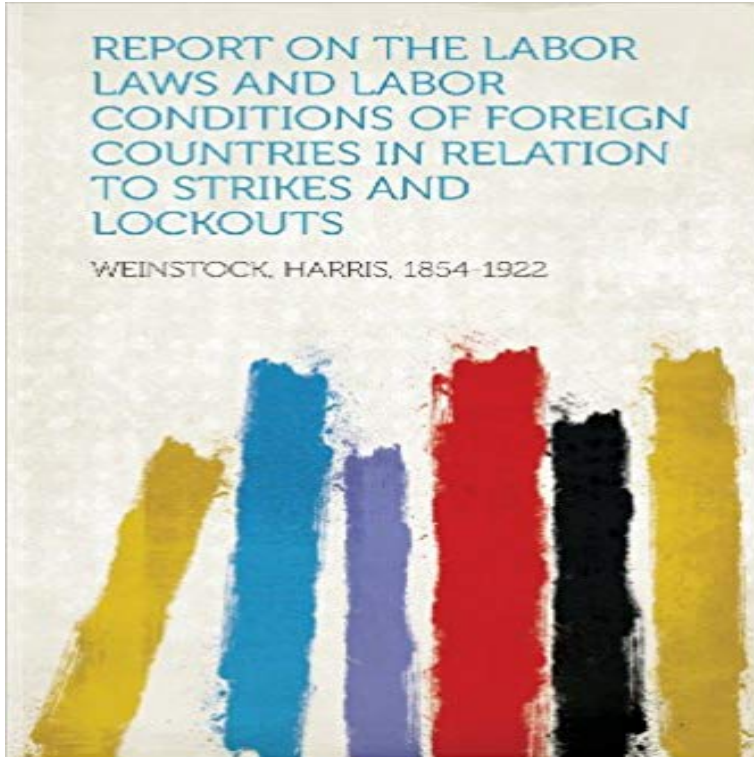


# Report on the Labor Laws and Labor Conditions of Foreign Countries in Relation to Strikes and Lockouts
