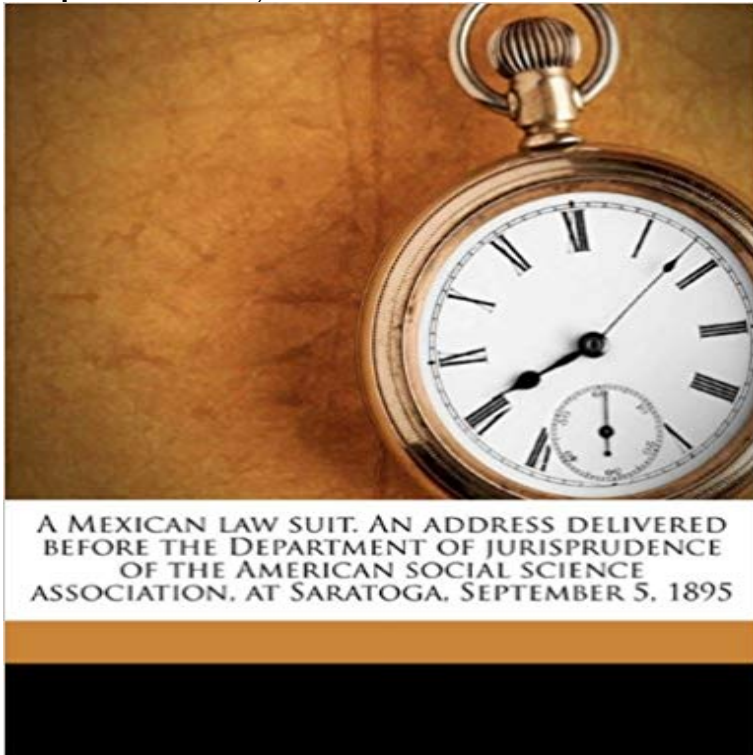


A Mexican law suit. An address delivered before the Department of jurisprudence of the American social science association, at Saratoga, September 5, 1895
