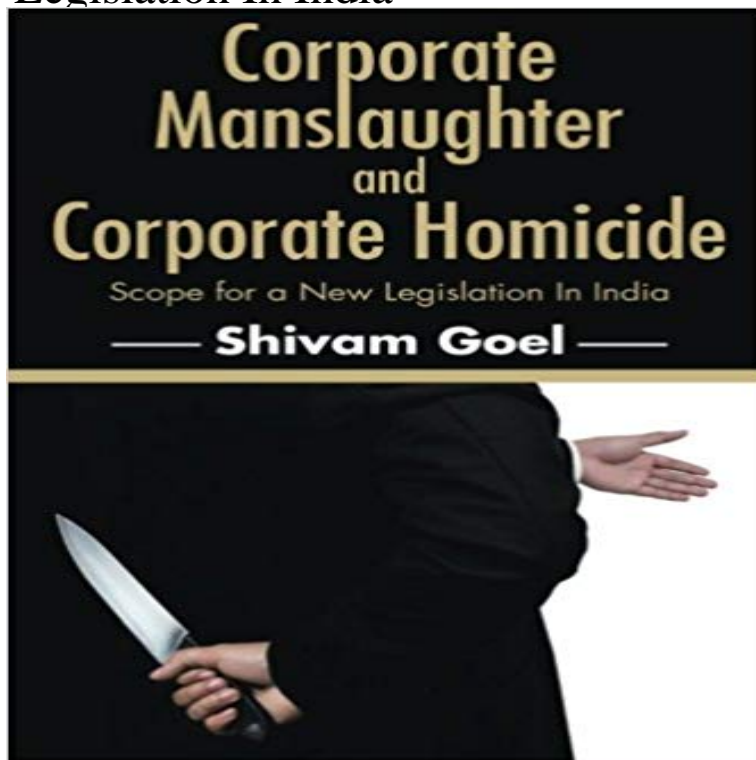


Corporate Manslaughter and Corporate Homicide: Scope for a New Legislation In India
